- Vice Chairman of the Broadcasting Authority of Zimbabwe. Supervised the creation of the Zimbabwe's first gazetted frequency spectrum and map. This was subsequently adopted by the International Telecommunications Union (ITU) as the official spectrum for television and radio waves.
